Welcome to the Autumn 2018 edition of the Adsec Newsletter



The Security Industry Authority (SIA) has begun what is describes as a wideranging review of the license linked qualifications. The security regulator says it is considering not just the mandatory qualifications it requires, mainly for door staff, manned security guards and public space CCTV operators, but any refresher training; and how to ensure the integrity of qualifications against exam fraud. The plan is to interview hundreds of operatives, and run focus groups. This work is scheduled to finish at the end of 2019, and the new qualifications will commence in January 2020. Steve McCormick, SIA Director of Operations and Standards says:

"This is a very important piece of work because we have a statutory responsibility to raise standards in the private security industry. Our aim is to improve the professionalism of security operatives, drive standards in the industry, and help protect the public in the UK. This will assist the industry to improve the standards of service delivery, and help with recruitment and retention".

At Adsec, we've experienced a reduction of the pool of available operatives for hire since Brexit has been announced, as have those we have discussed this with in other industries, whether it be security, logistics or warehousing. As we've always invested in training our staff, and believe this ethos, along with staff welfare and technology has helped us in retaining a solid workforce, we continue to trust that if we look after our staff, they will in turn protect the people in their care better.

In October it was surprising to see Mitie acquire Vision Security Group (VSG). As the second largest security provider in the UK purchases the fourth largest, they take a large step towards the scale of G4S's operations, who have dominated the private security sector. Often with large scale acquisitions and mergers, the service provided can tumble, while management lines and processes are reorganised. It will be interesting to see how this develops, and how many consumers are adversely affected. We're proud to be a dynamic, family run business, with service top of our agenda, and a portfolio ideally sized to focus on the individual needs of our clients.

Since our last issue, having commenced a number of contracts this year, with many staff transferring to Adsec, we've been working on refining our TUPE processes. When commencing new contracts, we re-define client expectations, provide clear communication of responsibilities, streamline transitions wherever possible, and support people through the process. We've also undertaken a review of our Cyber Security, and devised an action plan to enhance our threat protection. In an increasing world of online fraud, malware, phishing, randsomware and social engineering, it's imperative to secure your business from cyber crime.
