Opening statement from Teresa Barrett, Operations Director

What Brexit will mean and even if it will happen is still uncertain even with just a few short weeks to go until the 29 March deadline. We have gained full oversight of what the 2019 budget will look like as Philip Hammond MP announced that counter-terror police in the UK would receive £160m in additional funding and, whilst we could say there would never be enough, even in the austere times we live in, our counter-terror forces will welcome this funding.

UK Police have responded: We cannot do everything, alone. So, who can? Neil Basu, the Chief of Counter-Terrorism Policing, will look to make very tough decisions about how this money is spent, in a time where grass-roots policing could be more important than ever to build communities, stamp out hate crime and encourage a collective responsibility for our own safety.

Further, he has said he fears the far right will exploit Brexit tensions with their propaganda triggering rises in hate crime and creating an atmosphere that terrorists can exploit, and is concerned that far right-wing rhetoric from those lawfully allowed to operate will fuel tensions. He's apprehensive a no-deal Brexit will lead to a loss of intelligence and data-sharing with Europe and leave its 27 nations and Britain less safe and was of "deep concern".



Here at Adsec we've completed another busy Christmas period and have moved into the New Year with renewed optimism for 2019. Our Sales team continues to work hard to increase our portfolio of contracts. As part of our sales drive, we've issued a new incentive in the form of "Leads to Commission". If you're an EU citizen, you and your family will be able to apply to the EU Settlement Scheme to continue living in the UK after 30 June 2021. If your

application is successful, you'll get either settled or pre-settled status.

You may be able to **stay in the UK without applying** - for example, if you're an Irish citizen or have indefinite leave to remain (ILR).

The EU Settlement Scheme will open fully by 30 March 2019. You may be able to apply now if you meet the criteria. The deadline for applying will be 30 June 2021.

On 21 January the Prime Minister announced that there will be no fee when the scheme opens fully on 30 March 2019. Anyone who has applied already, or who applies and pays a fee during the test phases, will have their fee refunded. Details of the refunds process will be published shortly.

If you want to apply now, the fee has been suspended, if you have already applied, this will be refunded.

It'll be free to apply if you already have a valid 'UK permanent residence document' or you already have indefinite leave to remain in or enter the UK.

If you're an EU citizen or a family member of an EU citizen, you'll usually need to apply if you want to stay in the UK after 30 June 2021.

This includes if you either:

- Were born in the UK but are not a British citizen
- Are married to a British citizen and you're from the EU

You'll not usually be eligible to apply if you're married to a British citizen and you're from outside the EU.

The EU Settlement Scheme will open fully by 30 March 2019. You may be able to apply now if you meet the criteria.

You do not need to apply if:

- You're an Irish citizen your family members from outside either the UK or Ireland will still need to apply
- You have indefinite leave to enter the UK
- You have indefinite leave to remain in the UK

You can apply **if you already have indefinite leave to remain in or enter the UK**, but you do not need to.

Your family members from outside either the UK or Ireland will still need to apply even if you do not need to.

If you have a 'UK permanent residence document' You will still need to apply.
