Opening Statement from Teresa Barrett, Operations Director

On July 10 - 12, the Security Industry Authority (SIA) and HMRC (HM Revenue and Customs) carried out joint operations in London, Cardiff and Newcastle. Teams attended 65 venues and spoke to over 100 security operatives to check that they were legitimately employed, that all taxes were being paid, and to ensure they were not victims of any labour abuse.

During what the institutions described as a targeted operation, the SIA and HMRC teams discovered some operatives working self-employed, and some cases of cash-in-hand work.

As well as encountering operatives deployed by security companies, the teams found operatives working directly for the venue. HMRC are undertaking further enquiries with some of the findings. Follow up visits will be taking place with those businesses and venues that deploy front line operatives.

John Sandlin, Senior Manager at the SIA said: "This operation is to ensure that security staff are employed legitimately and treated fairly. By working together, our two organisations will challenge attempts to circumvent or manipulate the law. We want a level playing field for those legitimate businesses that play by the rules."

Simon York, Director of HMRC's Fraud Investigation Service, said: "Honest employers have nothing to fear, but we are determined to root out businesses who try to cheat the tax system and undercut those who abide by the law. These operations are part of our successful partnership with the SIA which help us identify tax abuses in the security industry. We are determined to ensure workers are treated fairly and to create a level playing field for businesses across this sector."

At Adsec we welcome this news. All our staff employed directly through a PAYE (pay as you earn) scheme, and we ensure all of our staff are licenced for the activity they are required to perform. We regularly check the progress of our officer's licence renewals, and even offer to assist by linking their application with Adsec, allowing us to manage the licence application process on behalf of applicants. We are encouraged that the SIA and HMRC are taking this positive action, to bring those operating outside their rules into line with the rest of the private security industry.



Our Sales team continues to work hard to increase our portfolio of contracts. As part of our sales drive, we've issued a new incentive in the form of "Leads to Commission". The scheme sets out that officers who provide information that may lead to us attaining new business, will be able to earn commission. You will find copies of the form within the site folder. SIA Approved Contractor Scheme (ACS) Audit Results

Following the changes to the scoring of the SIA Approved Contractor Scheme earlier this year, we are very happy to report that we passed our latest external audit. After a major review and overhaul to the ACS standard, the scoring system changed with effect from 1st April 2019. The previous top attainable score of 174 has reduced overall to 145.

By achieving a score of 112, we maintained our score as a percentage at 77% from the previous year. We found this particularly encouraging when our external auditor advised that most companies he'd audited since the changes, had attained 50-60% scores. So well done everyone at Adsec Group for maintaining our commitment to improvement in the provision of security services.
